This typically includes obtaining environmental permits for projects (Water Act CoP notifications, wildlife permits, Temporary Field Authorizations, etc.), explaining and summarizing permits to the client (what they have, what is missing), and conducting technical work (fish salvages, turbidity monitoring, ESC plans, site inspections, wildlife sweeps, weed surveys, bathymetric surveys, etc.). However, staff are also involved in other post-approval related activities such as groundwater monitoring, water quality monitoring, and wildlife studies.

The Manager of Environmental Assurance oversees this Division, ensuring high-quality project deliverables and adherence to CPP Environmental's mission and vision. This role involves supervising a multi-disciplinary team, managing multiple clients and projects, and fostering collaboration across divisions. The successful candidate



drives the completion of projects on time, on budget, and to a high standard. They ensure compliance with regulatory requirements, deliver quality outputs, and maintain strong client relationships.
